



Neutralising agent

Application:

 $ProCare\ Tex\ 30\ C$ is an acidic neutralising agent based on an organic acid to reduce alkalinity in commercial washing machines.

ProCare Tex 30 C is ideal for use in commercial laundry care, in particular in reprocessing flatwork. The product is dispensed in the last rinse cycle.

The ingredients are natural, are particularly gentle on the environment and ensure good process security.

Product properties:

- Effective in the temperature range from cold to 40 °C
- Can be used at all water hardness levels
- Very good neutralisation performance
- Stable, neutral pH values thanks to special buffer system
- Active against yellowish alkaline stains, even when laundry is stored in damp condition
- Free from fragrances
- Minimises unpleasant odours

Dispensing recommendation [ml per kg of laundry]:

Added to last rinse, depending on alkalinity of wash process $0.5-2.0~\mathrm{ml}$ per kg of dry laundry

ProCare Tex 30 C is designed to perform best in Miele Professional washing machines.

- Precise and economic dispensing via dispensing pump
- In the case of manual dispensing, the product is dispensed via the fabric conditioner compartment

Please note:

- Do not mix with other products.
- Operating instructions for Miele Professional washing machines must be observed.
- Before switching products, rinse the dispensing system, including suction hoses, with water.
