
Maintain

Validation

Legally required inspections for your field of dentistry or medicine

Both applicable laws and guidelines require validated processes to guarantee that no health risk can arise to patients, users or any third party from reprocessed medical devices. Our medical device technicians, specially trained to cover machines and application technology, perform qualification and revalidation work in accordance with the guidelines published by the relevant authorities.

Qualification (IQ/OQ)

Standardised inspections of cleaning systems for your industry

In the pharmaceutical, food-processing and cosmetics industries, all cleaning systems used in production, quality assurance and R&D must be qualified. Our specially trained medical device technicians are able to qualify (Installation Qualification/Operation Qualification) your machines and provide the necessary IQ/OQ documentation (standard documents).

Revalidation

Regular inspections to ensure process security

Revalidation generally takes place 12 months after validation and is repeated on an annual basis. Unscheduled revalidation is also particularly necessary whenever new programmes are introduced, process parameters changed, new chemicals, instruments or loading systems used or the quality of the water supply changes.

Annual Maintenance and Calibration

Transparent documentation of the parameters you define

In addition to maintenance and care, Miele Customer Service calibrates, documents and performs functional tests on measuring systems and componentry on board both the machine and peripheral units as an extended special service. IQ/OQ maintenance / calibration documents (standard forms) are provided by Miele.
